The opioid crisis continues to affect Canadians in your community and across the country.

Between January and December 2023,

7,947 Canadians were hospitalized due to opioid-related poisoning – approximately 4 per day in Quebec alone.^{2,3}

4 TIPS TO HELP YOUR PHARMACY TEAM PROACTIVELY DISPENSE THN KITS AND EDUCATE PATIENTS¹

GOAL: Everyone prescribed an opioid should receive a THN kit



EDUCATE AND ALIGN YOUR TEAM:

Align ALL staff in your pharmacy to proactively co-dispense naloxone

- Assign a staff naloxone champion to handle training and materials
- Give staff opportunities to practice positive, inclusive naloxone counselling strategies
- In-pharmacy signage about naloxone availability can put patients at ease



Get brochures, window stickers, demonstration devices, and more for your pharmacy



KNOW YOUR PATIENT:

Be mindful of stigma – both yours and the patient's

- Choose your words thoughtfully. For example, instead of saying "overdose", say that opioids can slow breathing if someone takes more than their body can handle
- Remind patients that anyone taking an opioid or with access to opioids can be at risk. It's important to have naloxone available and know how to use it



ADJUST WORKFLOW:

Make offering naloxone a standard process

- Identify opioid prescriptions during intake and prepare naloxone kits alongside them
- Assign a staff member to manage THN kit inventory and in-store signage
- · Understand the billing process for naloxone kits
- Set up alerts on opioid drug files to remind staff to proactively co-dispense naloxone
- Include naloxone recommendations with delivered prescriptions
- · Anticipate and manage competing priorities (flu, holiday season)
- · Assess gaps by comparing opioid and naloxone dispensing



BE A PHARMACY LEADER:

Help make a difference in your community through outreach

- Consider hosting opioid awareness days in your pharmacy or community
- Share your success stories and best practices with peers and colleagues
- Connect with community support groups to offer counselling and access to THN kits
